

GULF COUNTY SCHOOL BOARD

Wednesday, May 30, 2018

The Gulf County School Board met in special session Wednesday, May 30, 2018, at 8:30 (Workshop) and 9:00 (School Board Meeting) at their Administrative Office in Port St. Joe. Superintendent Norton, Attorney Costin, and the following board members were present: Chairman Brooke Wooten, Vice Chairman Cindy Belin, Billy C. Quinn, Jr., Danny Little, and John Wright.

WORKSHOP:

Chairman Wooten called the workshop to order at 8:30.

-Triumph Funds- Mr. Norton began the discussion by informing the Board on the district's TRIUMPH application status. There has been some miscommunication about the application process, but Triumph Board Member Jason Shoaf addressed the Board to bring clarification on the process of applying for Triumph funds. Mr. Shoaf encouraged and challenged the Board to *think outside the box* when applying for Triumph Dollars. He gave various examples of innovative things districts all around Gulf County are doing, and reminded the Board and district staff that he and the Triumph staff are available and eager to help Gulf be successful in obtaining their share of this funding.

-Coach Aaron Feis Guardian Program- Mr. Norton reminded the Board that the July deadline is quickly approaching for the Board to decide whether or not to participate in the Guardian Program. He advised the Board that he plans to have a recommendation before them at the June 5 meeting. Chairman Wooten asked board members to do their own personal research and soul searching and be prepared to vote yes or no to the Guardian Program at the June 5 meeting.

-School Funding for School Year 2018-2019- Mrs. Worley informed the Board that while the State had funded various safety initiatives in the wake of the Parkland tragedy, the per-student funding has decreased, which means we will be operating with less funding for school year 2018-2019. She also stated that the board is faced with the upcoming decision to either increase taxes, cut programs or cut personnel.

Chairman Wooten adjourned the workshop at 8:58.
