The Gulf County School Board met in regular session Thursday, September 8, 2016, at 5:00 (Agenda Workshop) 5:15 (Public Hearing on 2016-2017 Final Budget, and 5:20 (School Board Meeting) at their Administrative Office in Port St. Joe. Superintendent Norton, Attorney Costin, and the following board members were present: Chairman John Wright, Vice-Chairman Billy C. Quinn, Jr., Danny Little, and Linda R. Wood. Mr. Wooten was out of town and unable to attend the meeting.
