The Gulf County School Board met in regular session Tuesday, May 26, 2015, at 9:45 A. M. (Agenda Workshop) and at 10:00 A. M. (Board Meeting) at their Administrative Office in Port St. Joe. Superintendent Norton, Attorney Costin, and the following board members were present: Chairman Danny Little, Billy C. Quinn, Jr., Linda R. Wood, and Brooke Wooten.
