

# GULF COUNTY SCHOOL BOARD

Tuesday, August 1, 2023

The Gulf County School Board met in regular session Tuesday, August 1, 2023, at 4:45 (Agenda-Review Workshop) and 5:15 (Public Hearing on the 2023-2024 Millage Rates & Tentative Budget and School Board Meeting) at their Administrative Office in Port St. Joe. The following Board Members were present: Chairman Ruby Knox, Cindy Belin, Marvin Davis, and Denny McGlon. Mr. Norton, Mr. Costin, and Mr. Wooten were unable to attend the meeting. Assistant Superintendent Josh Dailey served as Superintendent Norton's designee at the meeting.

## PUBLIC HEARING ON TENTATIVE BUDGET / BOARD MEETING:


