The Gulf County School Board met in special session Thursday, October 19, 2023, at 7:45 (Agenda-Review Workshop) and 8:00 (School Board Meeting) at their Administrative Office in Port St. Joe. 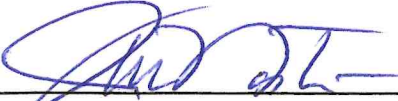
